## **Summary of Existing Summit Towers Parking Rules**

As of January 1, 2011

Please bring any questions to the office.

1. **Permits** are needed for parking anywhere on the Summit property. Cars without proper up-to-date permits are subject to being towed. Garage permits must be obtained in the office.

#### 2. Short term parking:

- a. Permits for parking in the lots outside the front doors can be obtained from either front desk. This permit is limited to one week. Only the Property Manager can extend these permits.
- **b.** Parking is available outside the Summit property at metered spaces.

#### 3. Long term parking:

- a. The Summit Towers Association owns some garage parking spaces. These can be rented only by owners and residents.
- b. Garage spaces can also be rented from owners with unused spaces. Owners who offer spaces must fill out a form in the office to authorize use of their space.
- c. The City of Hollywood provides very attractively priced monthly and annual permits for the metered spaces just outside our property. Information is available in office, <a href="https://www.hollywoodfl.org/parking/permits.htm">www.hollywoodfl.org/parking/permits.htm</a> or 954.932-3535.

# Rates and Rules for Renting a Garage Space from the Summit Towers Association

(approved by Summit Board 12/16/2010 for all new or renewed contract starting 12/17/2010)

#### Rates:

- Single space -- \$600/year or \$75/month (prices subject to change at renewal time)
- Connected pair of tandem spaces -- \$1000/year or \$100/month (tandems spaces only rented as a unit)

#### Rules:

- No registration is for longer than one year.
- No unit can be associated with renting more than two Association spaces at a time. For this purpose, a
  unit can be associated with renting two tandem pairs of spaces.
- Initial rental term start immediately upon registration.
- All spaces are given out on a first-come-first-serve basis in the office, with no reservations allowed.
- To ensure that you keep a space, it must be re-registered before expiration of the existing registration. Re-Registration is subject to the rules and rates at that time.
- To register unit owner or leasee must come to the office with payment, car registration, driver's license, and proof of insurance. Renewals can be done by mail.

### Parking permits and violation notices for residents and guests

**Updated May 15, 2013** 

Any car left anywhere on Summit property without a permit is subject to immediate towing.



# Garage parking for regular car in owned space

Get from business office.

Normally you will get also a automatic garage door opener. If you get a new car this must be replaced for \$75.



### Temporary Garage Permit

Get from business office.

Appropriate for rented car or a regular car in a space



# Garage parking for renters' cars

Get from business office. Provides right to park in space that belongs to the unit they are renting. The owner of the unit cannot use this space during the rental period.



# Outdoor Guest Parking Lot Permit

#### Get from front desks.

Maximum term 1-week without special exception from Building Manager. For guest only – not for residents or commercial use.

Of course, this permit does not guarantee a space if the lots are full.
